UCSF Development Office Leases Entire Floor at The Mills Building at 220 Montgomery Street

SAN FRANCISCO – December 17, 2007 – The Swig Company, a private real estate investment firm, announced that the University of California at San Francisco has signed a long term lease for 38,297 square feet at The Mills Building at 220 Montgomery Street.

Karl Baldauf and Liz Hart, both of Cornish & Carey Commercial's San Francisco office, represented The Swig Company in the transaction.

The lease, which covers the entire fifth floor of the 22-story building, was executed on behalf of UCSF's Development Office which will now move from its present location at 44 Montgomery Street. Occupancy is expected in the second quarter of 2008.

According to David Fuelle, Director of Leasing for The Swig Company, this is the largest single new lease signed in the building this year and brings total occupancy to more than 98% percent.
